## ROUTINE CARE

Overall Annual Limit: **R700**

Routine Care is included in the Solver Plan 100 and Plan 80 only. Benefits may be utilised towards any combination of the following specified treatments, if rendered and provided by a registered veterinarian:

- \* Annual vaccinations - (*injection fee, materials and drugs*)
- \* Deworming
- \* Tick & flea control - (*e.g. Frontline, Promeris, Program, etc.*)
- \* Dental scaling / polishing - (*procedure only*)
- \* Sterilisation

**NO EXCESS / DEDUCTIBLE ON ROUTINE CARE CLAIMS**

All insured animals must be identifiable by means of a microchip or an official tattoo as recognised by Solver Pet Medical Insurance.

## WAITING PERIOD

- You may claim for conditions and Routine Care (if applicable) which arise one calendar month or longer after the start date of your pet.
- There is a six calendar month's waiting period from the start date of your pet for cruciate ligament claims.

## EXCESS / DEDUCTIBLE

The excess deducted is the amount as per the option selected or 10% of the applicable benefit, whichever is the greater. The excess is per date of treatment for each and every claim. Similarly, the benefit percentage applied is as per the option selected. Accidental Injury Cover paid at 100% of vet's invoice less the excess.
